the building premises are found satisfactory on the following aspects.

- The Accommodation provided for each of the Rooms and halls is sufficient for the minimum number of peoples.
- The Sanitary arrangements provided are adequate and satisfactory, and Ventilation, lighting, that the building is maintained in substantial repair.
- The Drinking Water arrangements provided are adequate and satisfactory:
- All Laboratories, workshop are provided with First Aid Box with Emergency Medicines / Kids.
- That Latrine arrangements are adequate and Satisfactory.


THIS CERTIFICATE IS ISSUED SUBJECT THE FOLLOWING CONDITIONS:

- On any Account, the Garbage shall not be burnt or kept more than 24 hours in the Premise and should be collected and disposed by appointing required sanitary staff.
- Usage of Plastics is Prohibited.
- Fire Precautionary measures and First Aid Box Should be Provided.
- Child Labour should not be engaged on any account.
- Overhead Tank and Water Sump shall be hermetically sealed and scientifically closed and shall not be breeding sources of mosquitoes.
- Drinking water shall be Chlorinated and shall have 0.5PPM of Residual Chlorine.
- Fly/Mosquitoes Breeding shall not be Allowed within premises.
- Shall not cause nuisance to public health as defined in Tamilnadu Public Health Act,1939.
- Medical certificate for food handlers by the contractors must be obtained for catering in the premises.
- Hot lime wash / color wash to be done at least, once in year.
- Smoking or Chewing of Tobacco products strictly prohibited by law.

- Inspection note book shall be maintained & to be produced to public health authorities, during inspection.
- If the premises found to be in unauthorized building, NOC will be revoked ,without any notice.
- NOC from Fire & Rescue services Department to be obtained.
- Building Stability Certificate is to be obtained.
- TNPCB Consent Order for AIR & WATER is to be obtained.
- A minimum of one toilet with running water facility for 20 persons has to be provided in the premises.
- Bed spreads, if provided , to be washed, at least once a day, before utility.
- A minimum of 25 Sq. ft. area has to be provided for each person.
- Fresh air facility has to be provided for the inmates.
- Building approval should be obtained from Local Body /DTCP, Chennai.

This Certificate is Liable to be cancelled at any time on Infringement, if any of the Above Said Conditions and for improper maintenance of sanitation & building and if any, Health Nuisance is found as defined in Section 3 of TAMILNADU PUBLIC HEALTH ACT-1939.

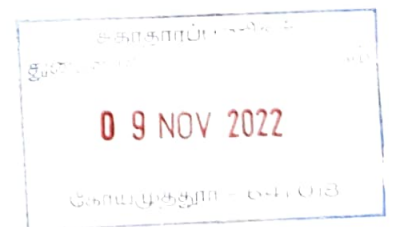
